It may invest up to 50% of its net assets in the securities of issuers in emerging markets.

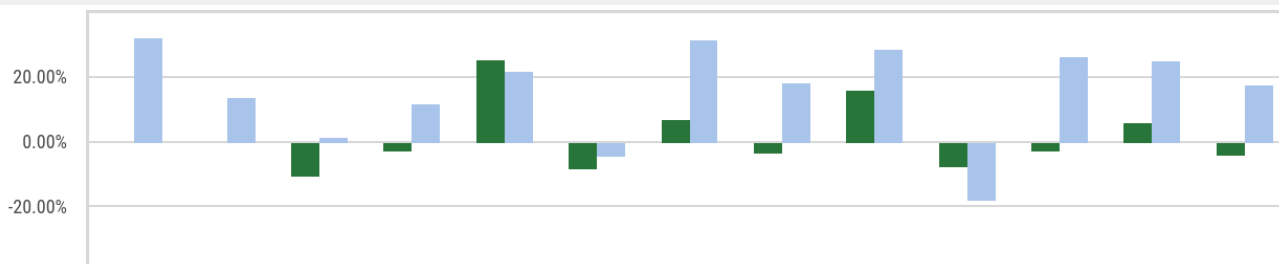
